6. DRAW

Entries must be received by 8:25:59 p.m. ET on May 23, 2024 (the "Closing Date"). The "Draw" will take place in public on May 23, 2024 at 8:30:00 p.m. ET on the Event Site.

During the Draw, one (1) Entry will be randomly selected from all eligible Entries received prior to the Draw Closing Date.
